The Township provides about 35% of the income. Fines, fees and grants account for less than 10%. The remaining 5% (or more) needs to come from donations. **Friends of the Library** is a key source of those donations. Also, it always helps the library's cause to say we have many Friends (translate into constituents)!

**Items purchased for the library with Friends donations:** 2007, all the magazine and newspaper subscriptions; 2006, new book covering system, a people counter, cabinets, book case, phone / telecom drops; **Prior years**, puppets, rugs, rocking chair, Fax machine, Hindi movies, magazine covers, book shelves, books.
